Pursuant to section 224(a) of the District of Columbia Board of Ethics and Government Accountability Establishment and Comprehensive Ethics Reform Act of 2011 (D.C. Official Code § 1-1162.24(a)), as amended, each Advisory Neighborhood Commission Commissioner (ANC), member of the Washington Metropolitan Area Transit Authority Board of Directors, and candidate for nomination for election, or election, to public office, who held the position for thirty days within the prior calendar year, is required to complete and submit this Public Financial Disclosure Certification (PFDC) to the Board of Ethics and Government Accountability (BEGA) annually, not later than May 15<sup>th</sup> of each year for the prior calendar year.

## **GENERAL INSTRUCTIONS**

### **WHO MUST FILE**

A Public Financial Disclosure Certification (PFDC) shall be filed by all Advisory Neighborhood Commission (“ANC”) Commissioners, members of the Washington Metropolitan Area Transit Authority Board of Directors, and candidates for nomination for election, or election, to public office, who held office for at least 30 days or ran their campaign during the prior calendar year.

### **WHEN TO FILE**

The PFDC shall be filed with the Board of Ethics and Government Accountability (BEGA) not later than May 15<sup>th</sup> of each year for the prior calendar.

A document is timely filed upon delivery to BEGA by 5:00 p.m. of the prescribed filing date. Statements sent by first class mail must be received by 5:00 p.m. on the prescribed filing date to be considered timely filed. An electronic report is timely filed by midnight of the prescribed filing date.

Please note that if you fit the description above of “Who Must File” you are required to file whether you receive a letter from BEGA notifying you of that requirement or not.

If you fail to file your PFDC by May 15<sup>th</sup> you will be subject to ministerial fines of up to \$300 imposed by the Director of Government Ethics for the failure to timely file.

### **HOW TO FILE**

This form may be filed electronically at [https://efiling.bega-dc.gov/efs\\_forms/login.asp](https://efiling.bega-dc.gov/efs_forms/login.asp) or by delivery of an original report to BEGA. If you file electronically, you must use the user ID, password, and PIN provided by BEGA to certify the report, thereby eliminating the signature requirement. Failure to certify your report will require that you provide BEGA with a signed copy of the report.

### **WHERE TO FILE**

A PFDC must be filed electronically as indicated above or mailed to the Board of Ethics and Government Accountability, 441 4<sup>th</sup> Street NW, Suite 830 South, Washington, D.C. 20001.
