A MESSAGE FROM THE DIRECTOR

As Summer draws to a close, things are continuing to heat up here at BEGA. Between reaching negotiated disposition in high-profile investigations, responding to requests for ethics advice and



conducting ethics training programs our staff members have their hands full as we head into Fall.

As mentioned in our last newsletter, we have started to initiate enforcement action against designated employees and public officials who failed to file their Financial Disclosure Statements (FDS) during the annual filing season that recently concluded. Late fees can be assessed against non-filers at a rate of \$10 per day up to a maximum of \$300, plus additional penalties may be imposed for deliberate noncompliance with the FDS filing requirements.

Lastly, we are looking forward to hosting our annual Ethics Day event on Thursday, October 3, 2019 here at One Judiciary Square. Once the full agenda for Ethics Day is finalized we will share it on our website and in next month's newsletter.

<u>Felice C. Smith</u> is Senior Counsel and Deputy Chief Ethics Officer with the Export-Import Bank of the United States, Office of Ethics.

Ms. Smith is an accomplished administrative law and federal ethics attorney with over 12 years of experience. As Deputy Chief Ethics Officer of the Export-Import Bank of the United States, she is responsible for day-to-day management of all aspects of the agency executive branch federal ethics program. Ms. Smith establishes training priorities for the Office of Ethics, develops strategic compliance solutions as part of the enterprise risk management program, and advises all staff, senior management, and the Board of Directors on Standards of Conduct and related federal ethics provisions. Having dedicated her legal career to public service, Ms. Smith has represented and advised various federal agencies in the legislative and executive branches since 2006, including the Library of Congress, Department of Justice, and Export-Import Bank. Ms. Smith has a breadth of experience in just about every subject area of law affecting federal agencies, including, employment law, intellectual property, anti-fraud and corruption, contract law, federal sector ethics, civil litigation, and safety and health compliance. Ms. Smith is also an Excellence in Government Program Senior Fellow with the Partnership for Public Service and a member of the U.S. Senate Toastmasters International Club.

A Ward 5 resident, Ms. Smith received a Bachelor of Arts in Political Science from University of North Carolina at Chapel Hill and a Juris Doctor from Howard University.

A Councilmember was fined \$20,000 for using Council time or government resources for purposes other than official business or other government-approved or sponsored activities; requesting his Chief of Staff to perform during regular working hours personal services on his behalf not related to her official government functions and activities; and knowingly using the prestige of his office or public position for his private gain.
