Agenda Item: Correspondence

- The Board reviewed a question from a member of the public regarding DCMR § 2542.2(b) on whether or not the resident manager must be physically present at the office they supervise. The Board's response to this inquiry is that the resident manager does not need to be physically present in the office being supervised.

- The Board reviewed a question from a member of the public regarding DCMR § 2531.11 on whether self-study continuing education is accepted at half of the credit recommended by the program sponsor. The Board's response to this inquiry is that, as the regulation states, continuing education for self-study and correspondence programs is accepted at "one-half" of the time recommended by the sponsor.

- Pursuant to § 2-575(13) and § 2-575(9) the Board unanimously voted to enter executive session at 10:25 AM to deliberate over the disposition of applications for licensure; as well as consider a disciplinary action against a licensee. The Board returned to open session at 10:32 AM.

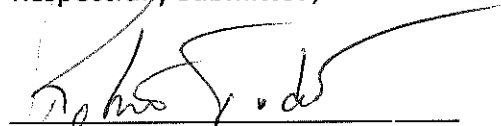
- The Board of Accountancy's next meeting is scheduled for Tuesday, 4 February 2014 beginning at 9:00 AM.
