- 3. Acknowledgement of Adoption of the Minutes of the July 29, 2014, meeting
  - Minutes from the July 29, 2014 meeting were approved by the committee
- 4. Report by the Chair and Co-Chair of MACCAN
  - Review of MACCAN mission
    - The mission of MACCAN was discussed following an individual review of the October 3, 2012 Mayor's Order 2012-164, Subject: Establishment-Mayor's Advisory Committee on Child Abuse and Neglect
    - Committee members were asked to share how they see themselves, their departments and/or agencies fitting into the mission
    - Joyce Thomas, President & CEO, Center for Child Protection and Family Support - In the field of child welfare for 40+ years, serves on a number of national panels addressing the intersection of domestic violence and child abuse & neglect
    - Question posed by Judge Breslow re: the Children's Justice Grant Act as a duty for the committee. Vice Chair Dr. Cheryl Boyce explained that this is no longer a duty for the committee and will be removed once the new order is issued. An update of the dollar amount received from the Children's Justice Act grant was requested to be provided for the next meeting.
    - Stephanie Minor Harper, Court Improvement Project Director at DC Superior Court, works to improve the handling of child abuse & neglect cases

- Toni Florence, U.S. Attorney's Office, prosecution of offenders
- **Recommendation** Committee will work to promote coordination and improve exchange of information between the U.S. Attorney's Office and the Office of the Attorney General
- Dr. Cheryl Boyce- Public Member, NIH, recommends spending time looking at **Family Strengthening as well Child Abuse Prevention** in 2015
- Yuliana Del Arroyo, Office of the State Superintendent of Education (OSSE), OSSE is a System of Care member- closely tied with other agencies around supporting families
- Review of Membership of MACCAN/Welcome of new members/ Vacancies
  - Recommended that the committee have a member from the charter schools
  - 4 Vacancies exist (Child Fatality, Department of Youth Rehabilitation Services, Community Based Child Welfare Provider, Department of Health)- Committee members to consider recommendations to fill these roles
