(Responsible charge) pages 6-7, 47-2853.116 - updated to include a definition for responsible charge.

(Scope of practice) for professional Landscape Architects.

Scope of practice for landscape architects is too broad as read. The scope and practice revised to model after the state of New York's practice and methodology for landscape architects.

The proposed revision was recommended to forward for 10 day review and response by American Society of Landscape Architects (ASLA) for comments and sign off.

Upon motion duly made by Mr. Nesmith and properly seconded by Mr. Touchette, the Board voted unanimously to approve the proposed legislation changes contingent on the approval from the ASLA.
