

Dear Councilmember McDuffie:

Welcome to the November 2017 Filing Season!

Recently, the Council amended the Ethics Act to require all Councilmembers to file Public Financial Disclosure forms twice a year.

You are receiving this letter because you are a Councilmember who must file a Financial Disclosure Statement with the Board of Ethics and Government Accountability twice a year on May 15th and November 15th. Your second filing for this year is due no later than Wednesday, November 15, 2017.

How to File:

You must submit your form by hard copy (for this filing season only). Please email or mail your form to BEGA no later than November 15, 2017. A copy of the form is attached for your convenience. Please mail your form to ***Board of Ethics and Government Accountability, One Judiciary Square, 441 4th Street, NW, 830 S, Washington, DC 20001*** or email it to ***bega-fds@dc.gov***.

It is important to remember that this filing requirement is mandatory and that BEGA will take enforcement action against all those who do not comply. Late filed forms may result in fines of up to \$300 and willful failure to file may result in fines of up to \$5,000.

Glossary of Terms

- **Financial Conflict of Interest prohibition** - No employee shall use his or her official position or title, or personally and substantially participate, through decision, approval, disapproval, recommendation, the rendering of advice, investigation, or otherwise, in a judicial or other proceeding, application, request for a ruling or other determination, contract, claim, controversy, charge, accusation, arrest, or other particular matter, or attempt to influence the outcome of a particular matter, in a manner that the employee knows is likely to have a direct and predictable effect on the employee's financial interests or the financial interests of a person closely affiliated with the employee.

- **Domestic partnership** is defined as the relationship between two persons who have registered as domestic partners under the District's registration procedures (DC Code § 32-701).

- **Gift**¹ – a payment, subscription, advance, forbearance, rendering, or deposit of money, services, or anything of value, unless consideration of equal or greater value is received. The term "gift" shall not include:
 - (A) A political contribution otherwise reported as required by law;
 - (B) A commercially reasonable loan made in the ordinary course of business; or
 - (C) A gift received from a member of the person's immediate family.

- **Income** - Income means all income from whatever source derived, including (but not limited to) the following items:
 - (1) Compensation for services, including fees, commissions, fringe benefits, and similar items;
 - (2) Gross income derived from business;
 - (3) Gains derived from dealings in property;
 - (4) Interest;
 - (5) Rents;
 - (6) Royalties;
 - (7) Dividends;
 - (8) Alimony and separate maintenance payments;
 - (9) Annuities;
 - (10) Income from life insurance and endowment contracts;
 - (11) Pensions;
 - (12) Income from discharge of indebtedness;
 - (13) Distributive share of partnership gross income;
 - (14) Income in respect of a decedent; and

(15) Income from an interest in an estate or trust.

*Honoraria are considered “income” for the purposes of this form.

- Confidential Financial Disclosure Statement (CFDS) –The form addresses the following:
 - Business Transactions: This consists of business entities transacting any business with the District of Columbia in which the public official (or spouse for jointly titled property) has a beneficial interest valued in excess of \$1,000.00, or serves as an officer, director, partner, employee, contractor, and consultant or in any other capacity. Business entities include sole proprietorships, partnerships and corporations.
 - Business Interest: Any business interest held by the public official (or spouse for jointly held property) in business entities transacting any business with the District of Columbia Government consisting of corporate stock, registered and traded on a national exchange, is listed only if the total value exceeds \$5,000.00.
 - Liabilities: Each outstanding liability borrowed by the public official (or spouse if a joint liability) exceeding \$1,000.00 which is not a loan from a federal or state insured or regulated financial institution, immediate family member, or revolving credit or installment account.
 - Real Property: All real property located in the District of Columbia (other than the personal residence actually occupied by the public official or spouse) that the public official or spouse (where jointly titled) holds an interest that has a fair market value in excess of \$1,000.00.
 - Licenses: Each professional or occupational license issued by the District of Columbia Government.
 - Gifts: All gifts received in excess of \$100.00 in a calendar period from any business entity **transacting business with the District of Columbia Government.**
